Who We Are

AvanTax Filing Services (<https://www.wefiletaxslips.com/OrderForm.pdf>) came to us by way of a request for help from a client who had run out of time to do their data processing; XML file preparation and slip printing & distribution internally. We helped them out of their jam and the rest is history.

What We Do

Quite simply, we take your raw data (in CSV, Excel or XML format) and import it into our system where we process it; check it for gross error; prepare and submit an XML file to Canada Revenue Agency and/or Revenu Québec; and prepare recipient slips for distribution by mail or email. We can even prepare electronic slips for distribution over a corporate portal.

We're in communication with you during the entire process; and, since we have a secure client portal, you'll not only be able to upload and download data securely but you'll also be notified immediately whenever new data or reports have been uploaded to your portal.
